Privacy Protection

At Dowds Group we take your privacy seriously and we are committed to protecting your personal data. This Privacy Notice sets out how Dowds Group uses and protects the personal data it collects and processes through your use of our websites and when you use our services. Dowds Group is the controller of the personal data you submit to us and responsible for your personal data under applicable data protection law.

Personal Data We Collect

Generally, you can browse this website without disclosing any personal information about yourself. We collect and store information that is automatically recognised when you visit the Dowds Group website to read or download information. For example, the date and time, the originating IP address, the domain name, the type of browser and operating system used (if provided by the browser), the URL of the referring page (if provided by the browser), the object requested and the completion status of the request.

Providing personal information on the Dowds Group website is optional, if you decide not to provide personal information, you can still use the website.

We collect the personal data relating to employment and general enquiries via forms on the website. This includes contact details (Name, Address, Email Address, Telephone &/or Mobile Number), employment history, qualifications and/or CVs.

We do not collect your data for any direct marketing purposes. We will not sell, distribute or lease your personal information to third parties.

What we do with the information we gather

The data will only be used to process your employment application, or respond to your enquiry.

In regard to employment applications, successful candidate's data will be held under the company's General Data Protection Policy details of which will be made available upon the offer of employment. Unsuccessful candidate's data will be held of a period of 12 months where upon it will be confidentially destroyed.

For general enquiries we will only hold your information for correspondence purposes and will appropriately dispose of it once your enquiry has been brought to a satisfactory conclusion.

Cookies

A cookie is a small file which asks permission to be placed on your computer's hard drive. Once you agree, the file is added and the cookie helps analyse web traffic or lets you know when you visit a particular site. Cookies allow web applications to respond to you as an individual. The web application can tailor its operations to your needs, likes and dislikes by gathering and remembering information about your preferences.



We use cookies to identify which pages are being used. This helps us monitor data about web page traffic and helps us provide you with a better website. We only use this information for statistical analysis purposes at an aggregate level to help us understand trends and patterns. This information is not reviewed at an individual level.
